**NOW, THEREFORE, BE IT RESOLVED** by the Zoning Board of Adjustment of the City of Millville, County of Cumberland, State of New Jersey, as follows:

3. Unless otherwise indicated, all regular meeting of the City of Millville Zoning Board shall be held on the dates indicated at City Hall, Commission Meeting Room, 4th Floor, located at 12 S. High Street, Millville, New Jersey at 6:00 p.m. No new matters will be commenced after 11:00 p.m. Meetings shall be open to the public unless the matter in discussion involves one or more matters set forth at NJSA 10:4-12(b). In the event that such matter is discussed, the public shall be excluded from that portion of the

meeting pursuant to resolution which shall be adopted in accordance with NJSA 10:4-13. At the conclusion of the closed session, the meeting shall be reopened to the public.

4. In the event of the necessity for holding a meeting of the City of Millville Zoning Board in addition to the meeting scheduled set forth in Paragraph 2 of this Resolution, the Board Secretary shall give written advance notice of at least forty-eight (48) hours giving the date, time, location, and, to the extent known, the agenda of any regular/special or rescheduled meeting. This notice shall state whether formal action may or may not be taken. Such notice shall be:

- a. Prominently posted on the bulletin board in City Hall, 12 S. High Street, Millville, New Jersey;
- b. Mailed, telephoned, e-mailed or hand-delivered to The Daily Journal, which is hereby designated as the official newspaper of the City of Millville Zoning Board;
- c. Mailed, telephoned, e-mailed or hand-delivered to The Atlantic City Press, or alternatively the South Jersey Times, which are hereby designated as additional official newspapers of the City of Millville Zoning Board;
- d. Filed with the City Clerk's Office.

5. The Board Secretary shall either post a copy of this Resolution or a copy of the scheduled meetings for the current year on the bulletin board in the Municipal Building and, in addition, shall public same in the official newspaper of the City of Millville Zoning Board as stated in Paragraph 4(B), above.

**AND BE IT FURTHER RESOLVED** that a copy of this Resolution be forwarded to the applicant and to all who request a copy for a reasonable fee. In addition, a copy of this Resolution shall be filed in the Office of the Clerk of the City of Millville.
