**RESOLUTION AUTHORIZING THE ADOPTION OF A CASH  
MANAGEMENT PLAN**

**WHEREAS**, the Board of Commissioners of the City of Millville desires to be in compliance with N.J.S.A 40A:5-14; and

**NOW, THEREFORE, BE IT RESOLVED** by the Board of Commissioners of the City of Millville that the following CASH MANAGEMENT PLAN be adopted effective immediately.

This plan is established to comply with the requirements of N.J.S.A. 40A: 5-14 and to provide a guide to municipal officials and employees in carrying out their duties concerning the receipt and disbursement and investment of City of Millville funds.

The following requirements shall be adhered to:

- A. The Board of Commissioners shall annually, at its reorganization meeting, designate the legal depositories for all municipal funds. The resolution may be amended or supplemented from time to time, as the Board of Commissioners deems necessary. Such resolution(s) shall be deemed a part of the Cash Management Plan.
- B. The Board of Commissioners shall establish, by resolution, the required signatories to all municipal bank accounts. The resolution may be amended or supplemented from time to time as the Board of Commissioners deems necessary.
- C. All municipal funds received by any official or employee shall be either deposited within 48 hours to an interest-bearing account in the name of the City of Millville, or shall be turned over to the Chief Financial Officer and/or Central Cashier within 48 hours of receipt.
- D. All revenues received by the Chief Financial Officer and/or Central Cashier shall be deposited into an interest-bearing account in the legal depositories, which are protected from loss under the provisions of the Governmental Unit Depository Protection Act (GUDPA).
- E. The City's Chief Financial Officer shall be in charge with administering the Cash Management Plan.
- F. The following funds shall not be required to be maintained in interest-bearing accounts:
  1. Change Funds
  2. Petty Cash Funds
  3. Payroll Funds
  4. Trust Funds to the extent that the deposit of such funds to an interest-bearing account would require by law the payment of interest to the provider of the funds.
  5. Checking accounts established for the express purpose of paying bills approved by the governing body. The balances in these funds shall be kept at the minimum amount required for the orderly operation of the account. The balances in these funds shall be kept in an interest-bearing account when prohibited by law.
  6. Compensating balances maintained for the purpose of obtaining specific services from financial institutions. Such accounts shall be established only under terms of written agreements approved by the Board of Commissioners.

- G. The Tax Collector and Utilities Collector(s) shall deposit all funds in a City interest-bearing account as directed by the Chief Financial Officer. All funds collected shall be reported to the Chief Financial Officer no later than 48 hours after deposit.
- H. No municipal funds shall be disbursed by the Chief Financial Officer prior to approval of the Board of Commissioners except for:
1. Debt Service Payments
  2. Investments
  3. Payroll and payroll turnovers to agencies
  4. Tax payments made to the County of Cumberland and the Millville Board of Education
  5. Special circumstances at the discretion of the Chief Financial Officer
  6. When a regularly bi-monthly scheduled City Commission Meeting is not held as scheduled due to cancellation or lack of quorum and payments are deemed necessary by the Chief Financial Officer

Payments to vendors as per items #4-6 above must be ratified after payment.

- I. The Chief Financial Officer is authorized to designate any Finance staff member to initiate or confirm/approve wire transfers.
- J. The Chief Financial Officer will disburse funds by purchase order following the requirements outlined below permitted by N.J.S.A. 40A:5-16 and N.J.A.C. 5:30-9A6.


